**THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION UNDER THE FLORIDA NOT FOR PROFIT CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:**

**ARTICLE I:** The name of the corporation shall be:

**ARTICLE II:** The principal place of business and mailing address of the Corporation shall be:

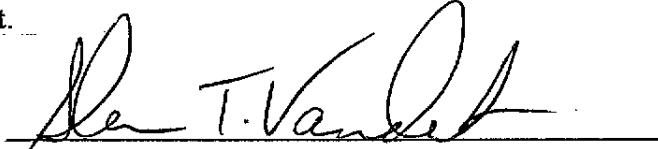

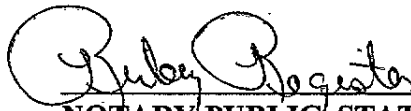
