Articles of Incorporation For the

ASHTON BIODIVERSITY RESEARCH & PRESERVATION INSTITUTE, INC.

A Florida Nonprofit Corporation

Article 1. - Name

The name of the Florida Nonprofit Corporation is:
ASHTON BIODIVERSITY RESEARCH & PRESERVATION INSTITUTE, INC.

Article 2. - Duration

The duration of the Corporation is perpetual.

Article 3. - Purposes

- A. This corporation is a not-for-profit corporation organized under Chapter 617 Florida Statutes. It is not organized for the private gain of any person. The purposes of the Florida Nonprofit corporation are as listed below:
- 1. to promote, support and provide opportunities for scientific research on upland biological diversity, and sustainable use of natural resources as a method of long term survivability of species and habitats, particularly research which promotes conservation of rare species, on the properties owned by Patricia S. Ashton and Ray E. Ashton. Jr. and called the Ashton Biological Preserve and Uplands Research Center properties and also called Finca de la Tortuga and any properties under habitat management with the Ashton Biological Preserve and Uplands Research Center any where in the world.
- 2. to promote, support and provide educational opportunities and training for students interested in upland natural history and biodiversity including interested amateur individuals, students, special interest groups, professionals and others at the properties owned by Patricia S. Ashton and Ray E. Ashton. Jr. and called the Ashton Biological Preserve and Uplands Research Center properties and also called Finca de la Tortuga and any properties under habitat management with the Ashton Biological Preserve and Uplands Research Center anywhere in the world.
- 3. to promote and support research applicable throughout Florida, the Southeast and throughout the World at or supervised by staff of the properties owned by Patricia S. Ashton and Ray E. Ashton. Jr. and called the Ashton Biological Preserve and Uplands Research Center properties and also called Finca de la Tortuga and any properties under habitat management with the Ashton Biological Preserve and Uplands Research Center on rare and endangered reptiles and amphibians as well as other species with the goal of establishing long term, sustainable populations.
- 4. to promote, support, and manage designated natural communities (wetlands and uplands) of the properties owned by Patricia S. Ashton and Ray E. Ashton. Jr. and called the Ashton Biological Preserve and Uplands Research Center properties and also called Finca de la Tortuga and any properties under habitat management with the Ashton Biological Preserve and Uplands Research Center to sustain and enhance the natural biodiversity.
- to raise funds to support facilities, staff, infrastructure, research, operations, management activities and to purchase equipment necessary to manage property or purchase real property or for any other use necessary to carry out the aforementioned goals of the corporation.

- 6. to facilitate communication among those involved in the efforts for study and preservation of biodiversity in keeping with the aforementioned goals of the corporation including exchange of ideas, techniques, and mutual assistance. Such communication will include, but not be limited to, print and electronic media, workshops, symposia, and conferences. Production and distribution of educational material for varied school grade levels and the general public may be included in these communication efforts. Communications will also be enhanced by acting as a clearinghouse of
- 7. Information among all agencies, organizations, and individuals involved in the research, preservation, conservation and management of biodiversity.
- to research, create, purchase, produce, market, sell, or in any other manner produce products or income for the support of the purposes and aforementioned goals of the corporation.
- B. This Corporation is also organized to exercise all rights and powers conferred by the laws of the State of Florida upon non-profit corporations.
- C. This Corporation shall not engage in any action which is not permitted to be carried on by non-profit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. - Members

The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.
