ARTICLES OF INCORPORATION

ARTICLE I – WORLDCLASS COLLIER, INC.

SECTION 1. NAME. The name of the corporation shall be WorldClass Collier, Inc.

ARTICLE II – OFFICE

SECTION 1. PRINCIPAL OFFICE. The principal place of business and mailing of this corporation shall be 3885 Huelva Ct., Naples, FL 34109.

ARTICLE III – PURPOSES

SECTION 1. SPECIFIC PURPOSES. The specific purposes for which the corporation is organized are to educate the people of Collier County about their School District, help to inspire and enhance the participation of the public in the promotion and support of the Collier County School District.
