ARTICLES OF INCORPORATION

OF

NOAH'S ARK RESCUE, INC.

A FLORIDA NOT FOR PROFIT CORPORATION

We, the undersigned incorporators, for the purpose of forming a corporation under Florida Not For Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be:

NOAH'S ARK RESCUE, INC.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSES

- 1. providing services dedicated to the rehabilitation and release of urban wildlife,
- 2. the care and adoption of domestic small animals, and/or
- 3. providing educational and animal health care clinics.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

The initial Directors of the corporation will be one and the same as the Incorporators as well as the Licensed Wildlife Rehabilitator/Asst. Co-Director listed herebelow. Once, annually, subsequent to the effective date, at a time and place agreeable to the current Directors, Directors shall either appoint or elect the same or other Directors to manage the affairs of the Corporation. Their term of office shall be one year.
