

ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida NOT FOR PROFIT Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

SUWANNEE VALLEY FELINE RESCUE, INC.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

10100 142ND ST. , LIVE OAK, FLORIDA 32060

ARTICLE III – PURPOSES

The specific purpose for which the corporation is organized is:

To provide for the health, care and maintenance of cats which are abused, abandoned, or otherwise in need of protection and other care, and to provide services and housing to provide for cats which may be adopted.

The Corporation is organized exclusively for charitable, educational, and Humane purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The Corporation may receive and administer funds for Humane, education, and charitable purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 and to that end, the Corporation is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgement of the directors, will best promote the purposes of the Corporation, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these

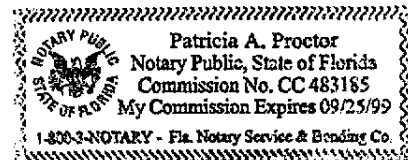
