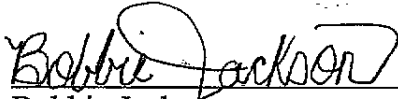

- TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and education purposes to aid individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited: Youth Education Development, Counseling, Tutorial Program, Computer Literacy, Study Center, Youth Community Enrichment, Youth at High Risk.

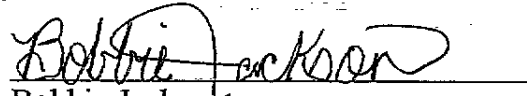
