

ARTICLES OF INCORPORATION

OF

LOVE JOY PAVILION OUTREACH MINISTRIES, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation shall be:

LOVE JOY PAVILION OUTREACH MINISTRIES, INC.

ARTICLE II

Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be:

1046 BLACKWOOD STREET
ALTAMONTE SPRINGS, FLORIDA 32701

The Board of directors may from time to time move the principal office to any other address in Florida, and so notify the Secretary of State.

ARTICLE III

Purpose(s)

The specific purposes(s) for which the corporation is organized is (are):

LOVE JOY PAVILION OUTREACH MINISTRIES, INC. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section(s) of any future federal tax code.

It is the purpose of this corporation to minister to all persons regardless of race, creed or color where ever possible and specifically in areas of gospel outreach; to provide assistance in as many areas as possible, with social and welfare needs of the local community or abroad.

The specific purposes of LOVE JOY PAVILION OUTREACH MINISTRIES, INC. are:

1. To disseminate the Gospel of Jesus Christ and the Word of God, for the purpose of conforming fellow Children of God into the image of Jesus Christ.
2. To provide biblical discipleship to believers on the domestic and foreign mission field.
3. To, by example and through counseling, influence families, conforming them into the healthy basic social unit portrayed in the Word of God.
4. To baptize, pray for the sick, to marry, to dedicate children, to practice communion, and to conduct funerals. To setup homes for the homeless, homes and care for the elderly, to rebuild the desolate areas and the wasted places.
5. To act with charitable concern for not only Christians, but also all people in need, regardless of race, social position, or religious affiliations.
6. The preaching of the gospel will be performed by pastors, elders, ordained ministers, evangelists, teachers, prophets, and apostles during the regular assembling of believers; through public and private study groups, seminars, workshops as well as the printing, reproduction and publication of recordings, books, and other materials.
7. To establish and implement an organized program to provide assistance and placement to battered women in the surrounding area.
8. To establish developmental day care programs in all areas without regard to the level of income of the community with special emphasis on the low income areas.
9. To work with various ministries both domestic and foreign.
10. To establish churches when and where needed.
11. To provide training and assistance to persons called to serve in the various offices of ministry, and preparing them for licensing, commissioning, ordination, and for service where ever called and in whatever task they are called to perform.

Offerings will be received to fund, grant aid, and to pay reasonable compensation to employees for these purposes; however, in no event will any monies or property received

by the Church be used for private profit or inure to the benefit of any member of the Board of Directors, employees or anyone in a position of authority.

ARTICLE IV

Manner of election of directors

The affairs of LOVE JOY PAVILION OUTREACH MINISTRIES, INC. (the Church) both spiritual and secular, shall be conducted by the Board of Directors, which shall consist, initially, of five (5). The number of Directors may be increased or decreased from time to time, but shall never be less than three (3). Directors shall be appointed according to the provisions set forth in the By-Laws.

The Directors themselves must possess the qualifications of leaders as set forth in the relevant teachings of the New Testament and they shall have the duties of Elders as set forth therein. Directors, once in office, shall serve so long as they remain members of the Church unless sooner removed as set forth herein.

The Directors shall appoint such other Elders as may be necessary to properly minister to the membership and carry out the purposes for which the Church is organized. Elders so appointed shall have the duties of Elders as set forth in the New Testament and subject to the provisions of Section 741.07, Florida Statutes, and to any rules or By-Laws which may be adopted by the Directors of the Church. They shall be authorized to conduct weddings and funerals. Once appointed they shall serve so long as they remain members of the Church, unless sooner removed as set forth herein.

The Board of Directors will make an effort to act with unanimity. However, all actions of the Board shall be with the concurrence of at least 3/4th's of the Directors, unless otherwise stated.

The Board of Directors shall be responsible for the maintenance of scriptural discipline within the Church membership as well as for the maintenance of membership standards. If the Board of Directors, after due examination of all the facts and circumstances, decides that a church member no longer fulfills the requirements for membership, the member shall be notified and their membership terminated.

If any decisions which cannot be successfully resolved at a meeting of the Board of Directors, the matter will be considered and a final decision made by the Pastor of LOVE JOY PAVILION OUTREACH MINISTRIES, INC.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: NONE

Additional powers of the corporation:

1. To provide a home base for missionaries desiring to serve in a foreign country;
2. To qualify for grants available for nonprofit projects;
3. To only engage in activities that further its religious, benevolent, charitable, literary and educational purposes. It shall engage only in such activities as are permitted to be carried on by corporations whose income is exempt from taxation pursuant to Section 501(c)(3), and whose contributions are deductible pursuant to Section 170(c)(2), of the Internal Revenue Code or future revisions.

No part of the activities of the corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

No part of the Church's net earnings or assets may inure to the benefit of any Director, officer or member, except for reasonable compensation for services actually rendered.

ARTICLE VI

DISSOLUTION

If it is necessary or desirable to dissolve the corporation, the provisions of s.617.1402, s.617.1403, and s.617.1406 shall govern. The corporation may be dissolved by a unanimous vote of the full Board of Directors. In the event of such dissolution, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation or to such organization(s) organized and operated exclusively for charitable, religious, educational, or scientific purposes as shall at the time qualify as a exempt organization(s) under Section 501(c)(3) of the Internal Revenue Code or the corresponding provision(s) of any future United States Internal Revenue Code or Law. The Board of Directors shall determine to whom distribution will be made, but in any case no distribution may be made to any organization not qualified under Section 501(c)(3).




