We, the undersigned, Steven J. Ponchot, Douglas H. Taylor and Brian T. Milgate, being persons legally competent to enter into contracts, for the purpose of forming a corporation under the laws of the State of Florida providing for the formation of religious, educational and benevolent corporation, do hereby adopt the following Articles of Incorporation.

**Article I Name**

The name of the Corporation shall be: **STUDIO 1029, INC.**

**Article II Address**

The principal place of business if known and the mailing address of this corporation shall be: Principal place of business not yet established. Mailing address: Steven J. Ponchot, 50 Mimosa Dr., Sarasota, FL, 34232

**Article III Purpose**

This Corporation is organized for the purpose of operating a church and any and all lawful businesses for which corporations may be incorporated under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes and shall have all the Corporate powers enumerated in the Florida Not For Profit Corporation Act.

**Article IV Directors**

Directors shall be selected by the Church Leadership Team that is elected/appointed by the congregation at an annual meeting.

#### **Article V A Non-Profit Corporation**

The corporate powers of this corporation are enumerated in Chapter 617 Florida Statutes.

#### **Article VI Initial Registered Office and Agent**

The street address of the initial registered agent of this corporation is 50 Mimosa Drive, Sarasota FL 34232. The name of the initial registered agent of this corporation at that address is Steven J. Ponchot.

#### **Article VII Conduct of Corporate Affairs**

The Corporation shall qualify for and become a corporation qualifying as a 501 (c) (3) corporation and all activities and conduct of the corporation shall be consistent therewith.

The organization is organized exclusively for charitable, religious, and educational purposes, including for such purpose the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code or corresponding sections of any future Federal tax code.

No part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of candidates for public office.

### **Article VIII Indemnification**

The Corporation shall indemnify any officer or director, or any former officer or director to the full extent permitted by law.

### **Article IX Bylaws**

The power to adopt, alter, amend bylaws shall be vested in the Pastor and the Leadership Team.

### **Article X Amendments**

This Corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or any amendment hereto.
