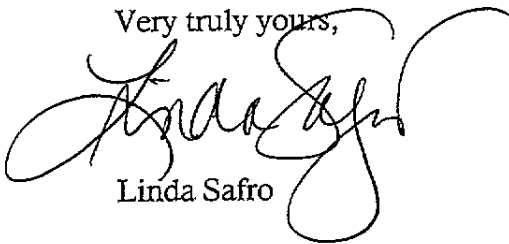

ARTICLE I
NAME

The name of this corporation is Source of Wisdom, Inc.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 8781 Holly Court, #210, Tamarac, Florida, 33321-2036.

ARTICLE III
PURPOSE

This purpose of this corporation is to promote and enlarge the learning of Torah and its various aspects and dimensions as the basis of the Jewish religion, and the performance of charitable activities.
