#### Constitution and By-Laws Preamble

This constitution and by-laws are established that the members of End Time Family Worship Ministries have an opportunity to know that God is a God of order. These articles and by-laws will insure each member a more harmonious walk in the light of God's Word and among his followers. The implementation of said constitution and by-laws shall be under the leadership of the Holy Spirit by the direction of the church Senior Pastor and Elders. We seek to establish and maintain this local church as a place of peace and worship of Almighty God. We the members, have willingly accepted and submitted ourselves to be governed by the following by-laws of Church order.

#### Article I. Name

The name of the corporation shall be:

This church fellowship shall be known as **End Time Family Worship Ministries Church, Inc.**  
It shall be and is a Florida Nonprofit Church Corporation.

#### Article II. Principal Office

The principal place of business and mailing address of the corporation shall be:

#### Article III Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

#### Statement of Faith

That the truth set forth in God's Word be established and manifested in the hearts and minds of his people, that they may go forth declaring these principles that are fundamental to the full-gospel message.

##### 1. The Holy Scriptures

We believe that The Holy Bible is The Word of The Living God; true, immutable, steadfast, unchangeable, as it's author, The Lord Jehovah; that it was written by Holy men of old as they were moved upon and Inspired by The Holy Spirit.

##### 2. The Eternal Godhead

We believe that there is but one true and Living God; maker of heaven and earth and all that in them is;

the Alpha and Omega, Who ever was, and is and shall be without end; that in unity of The Godhead there are three, equal in every divine perfection, executing distinct but harmonious offices in the great work of Redemption.

**The Father** -- whose glory is so exceedingly bright that mortal man cannot look upon His face and live; but whose heart was so filled with love and pity for His lost and sin-benighted children that He freely gave His only begotten Son to redeem and reconcile them back to Himself.

**The Son** -- Co-existent and co-eternal with The Father, Who, conceived by The Holy Spirit and born of the virgin named Mary, took upon Himself the form of man, bore our sins, carried our sorrow; and by the shedding of His precious blood upon the cross of Calvary purchased redemption for all that would believe upon Him; busting the bonds of death and hell, rose from the grave and ascended on high leading captivity captive, that as the Great Mediator betwixt God and man, He might sit at the right hand of The Father making intercession for whom He laid down His life.

**The Holy Spirit** -- The third person of The Godhead, The Spirit of The Father shed abroad, omnipotent, omnipresent, performing an inexpressible important mission upon the earth, convicting man of sin, of righteousness, and of judgment, drawing sinners to The Savior, rebuking, pleading, search, comforting, guiding, quickening, teaching, glorifying, baptizing, and enduing with power from on high, all who yield to His tender ministries, preparing them for the great day of The Lord's appearing.

### **3. The Fall of Man**

We believe that man was created in the image of God, before whom he walked in holiness and purity, but that by voluntary disobedience and transgression, he fell from the Eden of purity and innocence to the depths of sin and iniquity; and that as a consequence of this, all mankind are sinners sold unto Satan; sinners not by coercion but by choice, shaped in iniquity and utterly void by nature of the holiness required by the law of GOD, positively inclined to evil, guilty and without excuse, justly deserving the condemnation of a Just and Holy God.

### **4. The Plan of Redemption**

We believe that while we were yet sinners Christ died for us, the just for the unjust; freely and by divine appointment of The Father, taking the sinners place bearing his sins, receiving his condemnation, dying his death fully paying his penalty and signing with His life's blood, the pardon of everyone who should believe upon Him; that upon simple faith and acceptance of the atonement purchased on Mount Calvary, The vilest sinner may be cleansed of his iniquities and made whiter than the driven snow.

### **5. Salvation Through Grace**

We believe that the salvation of sinners is wholly through grace; that we have no righteousness or goodness of our own wherewith to seek divine favor, and must come, therefore, throwing ourselves upon the unfailing mercy and life of Him who bought us and washed us in his blood, pleading the merits and righteousness of Christ the Savior, standing upon His word and accepting the free gifts of His love and pardon.

### **6. The Baptism of The Holy Spirit**

We believe that the Baptism of The Holy Spirit is the outpouring of the promised Comforter in might and glorious fullness to endue the believer with power from on high and thus enable him for these purposes: to

glorify and exalt The Lord Jesus; to give inspired utterance in witness of Him; to foster the spirit of prayer, holiness and sobriety; to equip the individual and The Church for practical, efficient, joyous, Spirit-filled soul winning in the fields of life. We believe that this still being the dispensation of The Holy Spirit, the believer may have every reason to expect His outpouring to be after the same manner as that in which He came upon Jew & Gentile alike in Bible days and as recorded in The Word.

### **7. Speaking with other Tongues**

Are the physical evidence and sign that the Bible speaks of in Acts 2:4, 1Cor.12:4-10, 28. The baptism of the believers in the Holy Spirit, and that this experience is still a reality today for them that would believe and receive it, This tongues is the same as the gift of tongues, however, different in its purpose and use.

### **8. Sanctification**

Sanctification is the act of separation from evil, sin and the lusts of the world. In identifying with Christ and exercising faith in His sacrificial death and resurrection, the believer's sanctification becomes a reality.

### **9. The Local Church**

Jesus Christ is the head of the Church, His body, and shed blood are our source of authority and power. Each person that has accepted Christ and born of the Spirit is an important part of the Church of God. The Church is established to Evangelize the world, Worship God, and edify his body, who are them that believe in him. The Church mission is a divine command of the Lord Jesus Christ, to take the Gospel to the world, and to make disciples of all nations.

### **10. Divine Healing**

Perfect health is provided for in the atonement and is the privilege of every believer. Divine healing is part of the gospel of Jesus Christ. Matt:8:16-17, James 5:14-16

### **11. Ordinances of the Church**

**Water Baptism** - Baptism in water by immersion is commanded in the scriptures. Baptism symbolizes that the "born again" person has died with Christ and has been raised with Him in newness of life. This ordinance will be administered to all those who have repented of their sins and who have believed on the Lord Jesus Christ to the saving of their souls, giving clear evidence of their salvation.

**The Lord's Supper** - This we do in remembrance of the Lord suffering and death. All believers are to share in this memorial until the return of our Lord. This ordinance shall be observed regularly. It shall consist of bread / cracker and (non-alcoholic) grape juice.

### **12. The Second Coming of Christ**

We believe that the second coming of Christ is personal and imminent; that he will descend from Heaven in the clouds of glory with the voice of The Archangel and with the trump of God; and that at this hour, which no man knoweth beforehand the dead in Christ shall rise; then the redeemed that are alive and remain shall be caught up together with them in the clouds, to meet The Lord in the air; and that so shall they ever be with The Lord.

**13. The Millennial**

This is the time that Christ will visibly return with His saints to reign on the earth for one thousand years. There will be universal peace that mankind has never known at this time.

**14. The Judgment**

Whosoever name is not found in the Book of Life shall be cast into the lake of fire, receiving everlasting punishment and torment; while the righteous shall enter into everlasting life and peace, and God shall wipe away the tears from their eyes; and there shall be no more death, neither sorrow, nor crying, neither shall there be any more pain: for the former things shall have passed away.

**Article IV. Manner of Election of Directors**

The manner in which the directors are elected or appointed is:

Directors of the Board shall be selected, and approved by vote based on : Integrity, Experience in matters of Ministries and Business, and their Faithfulness to the Vision of End Time Family Worship Ministry. The manner in which the directors are elected is as stated in the By-Laws.

## By - Laws

### Articles VII. Prerogatives

#### **Section 1. Government (Self )**

The church shall have the right to govern itself according to the standards of the New Testament Scriptures. "Endeavoring to keep the unity of the spirit in the bond of peace ....till we all come into the unity of the faith .. unto the measure of the stature of the fullness of Christ." Ephesians 4:3-13.

#### **Section 2. Church Policy**

- (1.) To designate its own offices, to appoint committees, to arrange for its own meetings, and to govern itself in accordance with these By-Laws;
- (2.) To establish and maintain such departments, and services within the ministry for the propagation of the gospel and its work embraced by the purposes of the corporation;
- (3.) To examine candidates for ministry, and to license and ordain those who have been approved by the Senior Pastor/Chief Executive of this church according to the standards set forth by the New Testament;
- (4.) To examine candidates and appoint missionaries and to endorse and support missionary programs according to the standards set forth in the New Testament;
- (5.) To administer the ordinances of the church as defined in Article III of these By-Laws on a regular basis.

### Articles VIII. Membership

#### **Section 1. Qualification of Membership**

The membership of the church shall consist of persons who have confessed Jesus Christ to be their Lord and Savior and have requested by application, such membership with this organization, showing Christian testimony in the body of Christ.

#### **Section 2. Standard of membership:**

Individuals must meet the following requirements in order to be considered and or admitted as a member of this church body.

- 1.) Show evidence of a genuine born again experience.
- 2.) Your life as a Christian believer must be consistent.
- 3.) You must believe and subscribe to the statement of faith set forth in Article III of the Constitution.
- 4.) Must be willing to contribute regularly to the support of the church according to his / her ability, and attend regularly the services of this church.
- 5.) Must be willing to share in the organized work of this church in propagating the gospel of Jesus Christ.

#### **Section 3. Reception of New Members:**

Persons desiring to become members of the church after submitting an application to the church. The applicant having met membership requirements shall be received into the church publicly and their names shall be inscribed on the membership roll.

#### **Section 4. Discipline / Dismissal**

Enrolled members of the church may become proper subjects for discipline for the following reasons: promotion of discord and confusion, lack of harmony with the teaching and ministries of this church, not exhibiting a Godly Christian lifestyle, falling into sinful or worldly practices. Such member after charges have been made formal; that member shall be advised and counseled, based upon the determination by the Board of Directors, said member may be placed on probation to be determined by recommendation of Pastor or dismissal.

**Section 5. Restoration**

Any member whose membership has been withdrawn for any offense may be restored upon evidence of his or her repentance reformation, and after having personal conference with the Pastor of the church. Length of time of withdrawal may vary on circumstances and condition of withdrawal at the discretion of the pastor (ex: Asst. Pastor, Board of Directors, Deacons, ect.)

**Section 6. Business Meeting of Members**

The Business Meeting of the Members shall be scheduled from time to time doing the year. Said meetings may be Quarterly, Semi-annually, or Annually.

**Section 7. Place of Meeting**

Notwithstanding anything to the contrary in these By-laws, any meeting of this corporation may be held at any place, whether regular, special, or adjourned, within or without the State of Florida.

**Section 8. Active ( Voting ) Membership**

All active members of the church who are 13 years of age or over, who are on the active membership roll of this church and in good standing shall constitute the legal voting membership of the church. The Pastor and his wife shall be considered active voting members of this church.

**Section 9. Voting Rights**

Every member entitled to vote shall be entitled to cast one vote for each matter submitted to a vote of the member. A member may not cumulate votes. The affirmative vote of a majority of the voting power represented at the meeting, entitled to voting on any matter, shall be the act of the members. Proxy shall not be valid.

**Section 10. Quorum**

The majority presence in person of those members in attendance shall constitute a quorum for the transaction of business.

**Section 11. Amendments**

These By-Laws may be altered or amended by repeal and new additional By-Laws may be made from time to time at any regular or special meeting called for that purpose. A two-third's vote of the members in attendance at said meetings is necessary for changes. Due notice of such meetings and changes must be made verbally to the church members at the main worship service at least two Sundays prior to the scheduled date of the meeting.

## Articles IX. Board of Director

**Each member of the Board shall:**

- (1.) Shall be a born again Christian;
- (2.) Have received the baptism with the holy spirit according to Acts 2:4;
- (3.) Possess the qualifications stated in Acts 6:3 and 1 Tim. 3:8-13
- (4.) Be Spiritually, Scriptural, and intellectually sound; and be knowledgeable of domestic, current and economical and business affairs.
- (5.) Shall have been a member of End Time family Worship Ministries for at lease- one year; having been regularly and consistently in attendance at church services.
- (6.) Shall be consistent titers to End Time Family Worship Ministries as required by Malachi 3:10.

**Section 1. Number of Director /Offices (10) As Church Grow and more Directors are Required**

The offices of the corporation shall be the (1) President, Senior Pastor ( who shall serve as Chairman of the Board ) or his delegated designee; (2) Vice-President / Senior Director of the Board of Directors ( who shall be appointed by the Chief Executive and who shall take charge and Directorship of all Board activities in the absence of the Chairman of the Board); (3) the Treasurer who shall be elected);(4) The church Financial Secretary (who shall be elected) (5) the Church Clerk (who shall be elected) (6) Two Deacons ( who shall be elected); (7) Two(2) ETFWM members from the membership (who shall be elected ); (8) one(1) other person

(who shall be appointed by the Chief Executive / Senior Pastor.

\* All elected members of the Board shall be elected from the church membership by vote of the membership.

### **Section 2. Qualifications / Appointed Board Members**

Appointed Board Members must be professionals and may-be; but are not limited to members of End Time Family Worship Ministries. When appointed, members are to accommodate and serve the desire and goals of End Time Family Worship Ministries. These members of other organizations, are not required to attend regular services at ETFWMC or to be tithers at ETFWMC this requirement is automatically waived. However, they must be a member of a local church and a consistent tither to that church.

### **Section 3. Powers**

Subject to limitations of the Articles and these By- laws and of pertinent restrictions of the Corporation Code of the state of Florida, all of the activities and affairs of the corporation, but spiritual and temporal, shall be exercised by or under the direction of the Senior Pastor who is a member of the Board, and the other Advisory Board members. Without prejudice to such general powers, but subject to the same limitations, it is hereby expressly declared that the Board shall have the following powers:

- (a) To assist the Senior Pastor upon his request, in an advisory manner, in selecting and removing all the officers, and agents, of the corporation, prescribe such duties for them as may not be inconsistent with law, with the Articles of incorporation, or with these By- laws, to review and approve their compensation, evaluations, and merit increases when due.
- (b) To advise the Senior Pastor in making such disbursements from the funds and properties of the corporation as are required to fulfill the purposes of this corporation as are more fully set out in the Articles of Incorporation thereof, and generally to aid in the conducting, managing and controlling of the activities and affairs of the corporation and to help the Senior Pastor make rules and regulations therefore, not inconsistent with laws, with the Articles of incorporation or with these By- laws, as they may deem best suited.
- (c) To assist the Senior Pastor in adoption, making and using a corporate seal and to alter the form of such seal from time to time as the Senior Pastor may deem necessary.
- (d) To borrow money and incur indebtedness for the purposes of the corporation and to cause to be executed and delivered thereof, in the corporate name, promissory notes, bonds, debentures, deeds of trust, mortgages, pledges, hypothecation, or other evidences of debt and securities thereof.
- (e) To Quarterly, Semi-annually or Annually review and/ or adjust the Senior Pastor's salary.
- (f) To sell, convey, mortgage, lease or otherwise dispose of any real or personal property as may be necessary for the furtherance of its accordance with these By- laws, subject to the provisions of Article XI 11.
- (g) To provide for an annual external financial review of the church accounts. And provide for a full external audit every three(3) years.

## **Articles X. Church Offices**

**Section 1. Senior Pastor** - Shall remain in office as long as the call of God is upon his life, or is otherwise directed by the Holy Spirit. The pastor shall be overseer of the operations of the church and shall be directly responsible to God. He should have as his primary function to feed the flock of God, as the pastor is the undershepherd and Jesus is the Shepherd. The pastor shall have the total welfare of the church at heart.

**Section 2.** Shall be the President of the corporation. The President shall be the Chief Executive Officer of the corporation and shall, have general supervision, direction and control of the activities and offices of the corporation. As chairman he shall preside at all meetings of the Board of Directors, he or his designee. In addition the Senior Pastor shall be the spiritual overseer of the church and shall direct all its activities. His responsibilities shall include, but not be limited to, the following: He shall preside at all the services of the church, (he or his designee.) No person shall be invited to speak or preach in the church without his approval. He shall approve all such special meetings and conventions, conferences, as shall be deemed advisable. The usage of powers vested in the office of the Senior Pastor shall be checked and balanced by the Advisory Board.

**Section 3. Vice President**

In the absence or disability of the President, the Vice-President(s), in order of their ranks as fixed by the Board of Directors, the Vice-President designated as the Executive Vice-President, shall perform all the duties of the President, and when so acting shall have all the powers of, and be subject to all the restrictions upon, the President. The Vice-President shall have such other powers and perform such other duties as from time to time may be prescribed for them respectively by the Board of Directors or By-Laws.

**Section 4. Church Clerk**

The church clerk shall keep, or cause to be kept, a Book of minutes at the principal office or such other place as the Board of Directors may order, of all meetings of the members, the Board, and any committees of the Board, with the time and place of holding, whether regular or special, and if special, how authorized, the notice thereof given, the names of those present at the Board's and the committees' meeting, and the proceedings thereof. The clerk shall keep, or cause to be given, notice of all meetings of the Board and committees thereof required by these By-laws or by law to be given, shall keep the seal of the corporation in safe custody, and shall have such other duties as may be prescribed by the Board.

**Section 5. Treasurer**

The Treasurer shall be the Chief Financial Officer of the corporation and shall keep and maintain, or cause to be kept and maintained, adequate and correct accounts of the properties and business transactions of the corporation. The Treasurer shall deposit, all Moines and other valuables in the name and to the credit of the corporation with such depositories as may be designated by the Board of Directors. Disbursement of said funds of the corporation may be ordered by the board of Directors, as approved by the president.

**Section 6. Financial Secretary**

The Financial Secretary shall keep, or cause to be kept, ledgers of all financial activities of the corporation, at the principal office. The Financial Secretary shall keep, or cause to be kept records of cash flow, balance sheets, income and expense records, and quarterly business reports of the corporation. In the absence of the church Treasurer, the Financial Secretary becomes the Chief Financial Officer.

**Section 6. Deacons**

The Deacons shall represent an extension, when delegated of the pastor's ministry. The Deacons shall aid and assist the senior Pastor's in conducting and managing the activities of the church body needs. To assist the Pastor with the multiple tasks which comprise the spiritual guidance and ministry of the church, when such tasks are assigned to the Deacons by the Senior Pastor.

**Section 7. Resignation of Director**

Any director may resign, effective, upon giving written notice to the Chairman of the Board, or the Secretary, unless the notice specifies a later time for the effectiveness of such resignation.

**Article XI Settlement of Disputes****Section 1. Disputes Among Members**

In any irreconcilable dispute arising among the Board of Directors of the corporation and any member of the church pertaining to any matters of spiritual teaching or practices, church finances or title to property purchases with church contributions, the dispute shall be resolved finally by the Senior Pastor ( or his delegated designee), and / the Deacons ( or representatives of the Deacons ministry).

**Section 2. Disputes Among Directors**

In any irreconcilable dispute arising among the Deacons and / or the Board of Directors and/ or Elders of the church pertaining to any matters of spiritual teaching or practices, church finances or title to property purchased with church contributions, the dispute shall be resolved finally by the Senior Pastor (or his delegated designee), and / or the Board of Directors, and / or the Deacons ( or representatives of the Deacon or representatives of the Deacons ministry).

**Section 3. Procedure**

Any member or director involved in the dispute may present a letter signed by him or her to the Secretary of the corporation listing the grievance(s) and his or her desired action(s). The secretary shall notify the Senior Pastor of the grievance(s). Within 30 days of such letter, if the matter involves a member, the Senior Pastor shall inform the Board of Directors of the dispute and submit it to them for resolution. If the matter involves a dispute within the Board itself, the Senior Pastor shall decide the matter himself.

**Section 4. No Appeal to Court**

The decision made by the majority of the Board or by the Senior Pastor shall be final, and there shall be no appeal to any court from that decision.

**Section 5. Dispute with Senior Pastor**

If a dispute arises concerning the Senior Pastor, no action shall be taken unless a majority of the Deacons and Elders, combined, agree that such action is necessary in order to preserve the spiritual life and vitality of the church. The Senior Pastor will be presented with this determination of the Board and the Senior Pastor and the Board will meet and attempt to satisfactorily resolve the matter. This process shall be done in a confidential manner and none of those involved shall be free to communicate to individuals other than Board members concerning this matter.

**Section 6. Dispute with Senior Pastor (continued)**

If no resolution is able to be achieved within a reasonable period of time, the dispute will then be presented to members of the church. All communications made to members of the church concerning such a dispute shall be presented in as fair and objective a manner as possible.

Notice of the hearing of the members and a statement of the charges shall be served upon the Senior Pastor, who may be present at the hearing, who may offer evidence upon his behalf, who may confront and cross-examine any witnesses, and who may be represented by counsel at his own expense.

Upon a unanimous vote of all active members of the church, the Senior Pastor may be removed. There shall be no appeal to any court from that decision.

**Article XII Endorsements, Funds, and Disbursement****Section 1. Endorsement of Financial Documents**

All checks, drafts, demands for money and notes of the corporation, and all written contracts of the corporation shall be signed by such officer or officers, agent or agents, as the Board of Director designate. Each check shall be signed by two authorized individuals one being the President or Vice President.

**Section 2. Funds / Properties Received**

The corporation shall hold, manage and disburse any funds or properties received by it from any source in a manner that is consistent with the expressed purposes of this corporation.

**Section 3. Disbursement of Funds**

No disbursement of corporation money or property shall be made until it is first approved by the President or Executive Vice-President of the corporation or by a majority of the Board of Director. However, the Board of Directors shall have the authority, as delegated by the Senior Pastor, to appropriate specific sums to fulfill the objectives and purpose for which the corporation was formed and to direct the officers of the corporation from time to time to make disbursements to implement said appropriation.

**Article XIII Corporate Records and Reports****Section 1. Records**

The corporation shall maintain adequate and correct accounts, books and records of its business and properties. All such books, records and accounts shall be kept at its principal place of business in the State of Florida, as fixed by the Board of Directors from this time.

**Section 2. Inspection of Books or Records**

This corporation shall be open to inspection upon written request or demand of any member at any reasonable time, for a specifically stated purpose reasonably related to his or her interests as a member, and shall be exhibited at any time when required by the demand of any member's meeting.
