**ARTICLES OF AMENDMENT  
to  
ARTICLE OF INCORPORATION  
of  
END TIME FAMILY WORSHIP MINISTRIES CHURCH,  
INC.**

*(A church organized under the nonprofit corporation laws of Florida)*

Pursuant to the laws as stated in the Florida statutes, more specifically, the provisions of section 617.1006, Florida Statutes, the undersigned Florida non-profit corporation, **END TIME FAMILY WORSHIP MINISTRIES CHURCH, INC.**, adopts the following Articles of Amendment to its Article of Incorporation duly filed August 31, 1999, under the Florida Not for Profit Corporation Act.

**FIRST:** The Corporation hereby certifies and adopts the following amended articles in accordance with the laws of the state of Florida, and as authorized and set forth in the By Laws of the Corporation:

**ARTICLE III Purpose(s)**

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

More specifically, the Corporation shall provide religious charitable services to advocate the following enumerated religious beliefs, and to conduct the designated holy ordinances:

**Statement of Faith**

That the truth set forth in God's Word be established and manifested in the hearts and minds of his people, that they may go forth declaring these principles that are fundamental to the full-gospel message

**1. The Holy Scriptures**

We believe that The Holy Bible is The Word of The Living God; true, immutable, steadfast, unchangeable, as it's author, The Lord Jehovah; that it was written by Holy men of old as they were moved upon and Inspired by the Holy Spirit.

**2. The Eternal Godhead**

We believe that there is but one true and Living God; maker of heaven and earth and all that in them is; the Alpha and Omega. Who ever was, and is and shall be without end; that in unity of The Godhead there are three, equal in every divine perfection, executing distinct but harmonious offices in the great work of Redemption.

**The Father** -- whose glory is so exceedingly bright that mortal man cannot look upon His face and live; but whose heart was so filled with love and pity for His lost and sin-benighted children that He freely gave His only begotten Son to redeem and reconcile them back to Himself.

**The Son** – Co-existent and co-eternal with the Father, Who, conceived by The Holy Spirit and born of the virgin named Mary, took upon Himself the form of man, bore our sins, carried our sorrow, and by the shedding of His precious blood upon the cross of Calvary purchased redemption for all that would believe upon Him; busting the bonds of death and hell, rose from the grave and ascended on high leading captivity captive, that as the Great Mediator betwixt God and man, He might sit at the right hand of The Father making intercession for whom He laid down His life.

**The Holy Spirit** – The third person of The Godhead, The Spirit of The Father shed abroad, omnipotent, omnipresent, performing an inexpressible important mission upon the earth, convicting man of sin, of righteousness, and of judgment, drawing sinners to The Savior, rebuking, pleading, searching, comforting, guiding, quickening, teaching, glorifying, baptizing, and enduring with power from on high, all who yield to His tender ministries, preparing them for the great day of The Lord's appearing.

### **3. The Fall of Man**

We believe that man was created in the image of God, before whom he walked in holiness and purity, but that by voluntary disobedience and transgression, he fell from the Eden of purity and innocence to the depths of sin and iniquity; and that as a consequence of this, all mankind are sinners sold unto Satan; sinners not by coercion but by choice, shaped in iniquity and utterly void by nature of the holiness required by the law of GOD, positively inclined to evil, guilty and without excuse, justly deserving the condemnation of a Just and Holy God.

### **4. The Plan of Redemption**

We believe that while we were yet sinners Christ died for us, the just for the unjust; freely and by divine appointment of The Father, taking the sinners place bearing his sins, receiving his condemnation, dying his death fully paying his penalty and signing with His life's blood, the pardon of everyone who should believe upon Him; that upon simple faith and acceptance of the atonement purchased on Mount Calvary, The vilest sinner may be cleansed of his iniquities and made whiter than the driven snow.

### **5. Salvation Through Grace**

We believe that the salvation of sinners is wholly through grace; that we have no righteousness or goodness of our own wherewith to seek divine favor, and must come, therefore, throwing ourselves upon the unfailing mercy and life of Him who bought us and washed us in his blood, pleading the merits and righteousness of Christ the Savior, standing upon His word and accepting the free gifts of His love and pardon.

### **6. The Baptism of The Holy Spirit**

We believe that the Baptism of The Holy Spirit is the outpouring of the promised Comforter in might and glorious fullness to endue the believer with power from on high and thus enable him for these purposes: to glorify and exalt The Lord Jesus; to give inspired utterance in witness of Him, to foster the spirit of prayer, holiness and sobriety; to equip the individual and The Church for practical, efficient, joyous, Spirit-filled soul winning in the fields of life. We believe that this still being the dispensation of The Holy Spirit, the believer may have every reason to expect His outpouring to be after the same manner as that in which He came upon Jew & Gentile alike in Bible days and as recorded in The Word.

### **7. Speaking with other Tongues**

Are the physical evidence and sign that the Bible speaks of in Acts 2:4; I Corinthians 12:4-10, 28. The baptism of the believers in the Holy Spirit, and that this experience is still a reality today for them that would believe and receive it. This tongues is the same as the gift of tongues; however, different in its purpose and use.

## **8. Sanctification**

Sanctification is the act of separation from evil, sin and the lusts of the world. In identifying with Christ and exercising faith in His sacrificial death and resurrection, the believer's sanctification becomes a reality.

## **9. The Local Church**

Jesus Christ is the head of the Church, His body, and shed blood are our source of authority and power. Each person that has accepted Christ and born of the Spirit is an important part of the Church of God. The Church is established to Evangelize the world, Worship God, and edify his body, who are them that believe in him. The Church mission is a divine command of the Lord Jesus Christ, to take the Gospel to the world, and to make disciples of all nations.

## **10. Divine Healing**

Perfect health is provided for the atonement and is the privilege of every believer. Divine healing is part of the gospel of Jesus Christ. Matthew 8:16-17; James 5:14-16.

## **11. Ordinances of the Church**

**Water Baptism** – Baptism in water by immersion is commanded in the scriptures. Baptism symbolizes that the "born again" person has died with Christ and has been raised with Him in newness life. This ordinance will be administered to all those who have repented of their sins and who have believed on the Lord Jesus Christ tot he saving of their souls, giving clear evidence of their salvation.

**The Lord's Supper** – This we do in remembrance of the Lord suffering and death. All believers are to share in this memorial until the return of our Lord. This ordinance shall be observed regularly. It shall consist of bread / cracker and (non-alcoholic) grape juice.

## **12. The Second Coming of Christ**

We believe that the second coming of Christ is personal and imminent; that he will descend from Heaven in the clouds of glory with the voice The Archangel and with the trump of God; and that at this hour, which no man knoweth beforehand the dead in Christ shall rise; then the redeemed that are alive and remain shall be caught up together with them in the clouds, to meet The Lord in the air; and that so shall they ever be with The Lord.

## **13. The Millennial**

This is the time that Christ will visibly return with His saints to reign on the earth for one thousand years. There will be universal peace that mankind has never known at this time.

## **14. The Judgment**

Whosoever name is not found in the Book of Life shall be cast into the lake of fire, receiving everlasting punishment and torment; while the righteous shall enter into everlasting life and peace, and God shall wipe away the tears from their eyes; and there shall be no more death, neither sorrow, nor crying, neither shall there be any more pain; for the former things shall have passed away.

## **ARTICLE IX – SENIOR PASTOR**

The Senior Pastor of End Time Family Worship Ministries, Inc. shall occupy and maintain the office of President of the Corporation in accordance with sections 1 and 2, Article X-Church Offices, of the By Laws of End Time Family Worship Ministries, Inc. The Founding Senior Pastor of End Time Family Worship Ministries, Inc. shall be the following named person whose address shall be the same as the *initial* principal office of the Corporation as set forth in the Article Second hereof: *Albert R. Nottage*.

The Senior Pastor shall exercise a general superintendence and direction over the affairs of End Time Family Worship Ministries, Inc. as to the manner of operation for discharging transactions, formal religious procedures, and ecclesiastical duties.

The criterion of qualifications for the office Senior Pastor and the manner of investiture shall be as set forth in and regulated by the ecclesiastical authority of the Holy Bible, and the By Laws of the Corporation.

## **ARTICLE X – PROMULGATION AND ENFORCEMENT OF RULES AND REGULATIONS**

The Senior Pastor is hereby authorized and empowered to promulgate and enforce such rules and regulations as are necessary to avert, restrain, or quell intense antagonism and excessive hostility, threatened or actual, during any church crisis declared by the Senior Pastor to exist. In order to protect the ecclesiastical welfare and stability, prevent nuisance and menace, safeguard church property from actual or constructive damage or destruction, refute overt viciousness, and to maintain peace, tranquility, and good order and normalization in the church, these rules and regulations shall have immediate full force and effect, and shall affect such ministers, officers, trustees, directors, members, and persons as in the judgment of the Senior Pastor shall best provide for the protection of persons and property where aggressive provocation, belligerence and intimidation exist or are threatened among the members of the End Time Family Worship Ministries, Inc.

## **ARTICLE XI – EXTRAORDINARY EMERGENCY POWERS**

The Senior Pastor is hereby authorized and empowered to take such measures and to do all and every act and thing which he may deem necessary in order to prevent covert and overt acts of insurgence and rebellion, to the members of the church, and to maintain peace, tranquility, and good order in the church, and in any component part thereof, and in any area of the organization designated by the Senior Pastor.

The Senior Pastor is hereby further authorized and empowered, to cope with said covert and overt acts of insurgence and rebellion, to order and direct any ministers, officers, trustees, directors, members, and persons, or group of persons to do any act which would in the Senior Pastor's opinion prevent a breach of the peace and tranquility, or the Senior Pastor may order such ministers, officers, trustees, directors, members, and persons, or group of persons to refrain from doing any act or thing which would, in the Senior Pastor's opinion, encourage, increase, or prolong intense antagonism and excessive hostility, threatened or actual, during any church crisis.

In all such cases, the Senior Pastor is authorized and empowered to take and exercise any appropriate actions, powers, and prerogatives to avert any internal organizational activity that would in the Senior Pastor's opinion, endanger the existence of the church, or tend to cause, a breach of the peace, or endanger the peace and good order of the church, and shall have full power by appropriate means to enforce such authorized actions.

## **ARTICLE XII - PROHIBITIONS**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of the purposes set forth in Article Third hereof.

No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) and political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

Moreover, notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

## **ARTICLE XIII - CAPITAL STOCK**

The Corporation shall have no capital stock and shall be composed of members rather than shareholders.

## **ARTICLE XIV - QUALIFICATIONS OF MEMBERSHIP**

The criterion and conditions of membership qualifications for Christian fellowship and the manner of admission shall be as set forth in and regulated by the ecclesiastical authority of the Holy Bible, and the By Laws of the Corporation.

## **ARTICLE XV - VOTING RIGHTS**

Members of the Corporation will have such voting rights as are provided in the By Laws of the Corporation.

## **ARTICLE XVI - LIABILITIES FOR DEBTS**

Neither the pastor, ministers, officers, directors, nor members of the Corporation shall be liable for the debts of the Corporation.

## **ARTICLE XVII - AMENDMENT**

The Articles of Incorporation may be amended in the manner provided by law. Every Amendment shall be approved by the Board of Directors, proposed by them to the Members, and approved to a Members' meeting by a majority of the Members, unless all the Directors and all Members sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.



### ARTICLE XVIII - INDEMNIFICATION

The Corporation shall indemnify a director of the Corporation who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the director or officer was a party because the director or officer is or was a director or officer of the Corporation against reasonable attorney fees and expenses incurred by the director or officer in connection with the proceeding.

The Corporation may indemnify an individual made a party to a proceeding because the individual made a party to a proceeding because the individual is or was a director, officer, employee or agent of the Corporation against liability if authorized in the specific case after determination, in the manner required by the Board of Directors, that indemnification of the director, officer, employee or agent as the case may be, is permissible in the circumstances because the director, officer, employee, or agent has met the standard of conduct set forth by the Board of Directors.

The indemnification and advancement of attorney fees and expenses for directors, officers, employees and agents of the Corporation shall apply when such persons are serving at the Corporation's request while a director, officer, employee or agent of the Corporation, as the case may be, as a director, officer, partner, trustee, employee or agent of another foreign or domestic corporation, partnership, joint venture, trust, employee benefit plan or other enterprise, whether or not for profit, as well as in their official capacity with the Corporation.

The Corporation also may pay for or reimburse the reasonable attorney fees and expenses incurred by a director, officer, employee, or agent of the Corporation who is a party to a proceeding in advance of final disposition of the proceeding.

The Corporation also may purchase and maintain insurance on behalf of an individual arising from the individual's status as a director, officer, employee or agent of the Corporation, whether or not the Corporation would have power to indemnify the individual against the same liability under the law.

All references in these Articles of Incorporation are deemed to include any amendment or successor thereto. Nothing contained in these Articles of Incorporation shall limit or preclude the exercise of any right relating to indemnification or advance of attorney fees and expenses to any person who is or was a director, officer, employee, or agent of the Corporation or the ability of the Corporation otherwise to indemnify or advance expenses to any such person by contract or in any other manner.

If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be severable and provisions remaining shall not be otherwise affected. All references in these Articles of Incorporation to "director," "officer," "employee," and "agent" shall include the heirs, estates, executors, administrators, and personal representatives of such persons.

### ARTICLE XIX - SETTLEMENT OF DISPUTES

The Corporation agrees that it will settle internal disputes in accordance with scriptural criterion, church policy, and divine directives, as set forth in and regulated by the ecclesiastical authority of the Holy Bible, and Article XI - Settlement of Disputes, of the By Laws of End Time Family Worship Ministries Church, Inc.

### ARTICLE XX - COVENANT NOT TO SUE

The Corporation agrees that it will never institute any action or suit at law or in equity against any pastor, director or officer of the Corporation, nor institute, prosecute, or in any way aid in the institution or prosecution of any claim, demand, action, or cause of action for damages, costs, loss of services, expenses,

or compensation for or on account of any damage loss or injury either to person or property, or both, whether developed or undeveloped, resulting or to result, known or unknown, past present, or future, arising out of a pastor, director or officer of the Corporation's service to the Corporation.

#### **ARTICLE XXI - DEDICATION AND DISTRIBUTION OF ASSETS**

Assets of the Corporation are permanently dedicated to the furtherance of the specified exempt purposes set forth in Article Third hereof, within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

#### **ARTICLE XXII - DISSOLUTION**

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or shall be distributed to the federal government, or to a state or local government for public purpose.

However, if a named recipient is not then in existence or no longer a qualified distributee or unwilling or unable to accept the distribution, then the assets of this Corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code. Reliance may be placed upon Florida state law to establish permanent dedication of assets for exempt purposes.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### **ARTICLE XXIII - TERM OF EXISTENCE**

The Corporation shall have perpetual existence. The Corporate existence commenced on August 31, 1999.

#### **ARTICLE XXIV - EFFECTIVE DATE**

These Articles of Amendment to Articles of Incorporation of End Time Family Worship Ministries Church, Inc. shall be effective immediately upon approval of the Secretary of State, State of Florida.

**SECOND:** The date of adoption of the aforesaid Articles of Amendment to Article of Incorporation of End Time Family Worship Ministries Church, Inc., was the 23rd day of February, 2000.

**THIRD:** The aforesaid Articles of Amendment to Article of Incorporation were presented to the members of End Time Family Worship Ministries Church, Inc. by the Board of Directors, in the manner set forth in and regulated by the By Laws of the Corporation.

The amendments were adopted by the members, and the number of votes cast for amendment was sufficient for approval.

IN WITNESS WHEREOF, we have hereunto set our hand and seal acknowledged and filed pursuant to section 617.01201, Florida Statutes, the foregoing Amended Articles which comprise the Articles of Amendment to Article of Incorporation of End Time Family Worship Ministries Church, Inc., a nonprofit charitable organization, under the laws of the State of Florida this 23rd day of February, 2000.


