

ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

[1]Said Church of Christ, Inc. of Central Volusia is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) under the Internal Revenue Code, or the corresponding section of any future federal tax code.

[2] No part of the net earnings of the Church of Christ, Inc. of Central Volusia shall inure to the benefit of, or be distributable to its members to its members, trustees, officers or other private persons, except that the Church of Christ, Inc. of Central Volusia shall be authorized and empowered to pay reasonable compensation for the services and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the Church of Christ, Inc. of Central Volusia shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Church of Christ, Inc. of Central Volusia shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

[3] Notwithstanding any other provision of these articles, the Church of Christ, Inc. of Central Volusia shall not carry on any other activities not permitted to be carried on (a) by Church of Christ, Inc. of Central Volusia exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or the Church of Christ, Inc. of Central Volusia, contributions to which are deductible under section 107(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

[4] Upon dissolution of the Church of Christ, Inc. of Central Volusia, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or a state or local government, for a public purpose.
