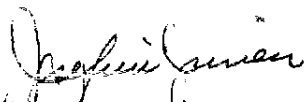

The undersigned, acting as incorporator(s) of the Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of incorporation:

## ARTICLE I

The name of the corporation shall be:

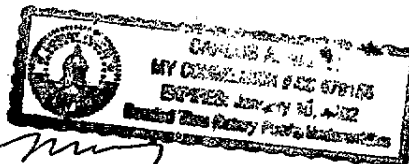
