## ARTICLE III PURPOSE(S):

RELY ON CHRIST MINISTRIES, INC., HAS BEEN ESTABLISHED TO MINISTER TO THE NEEDS  
OF THE HOMELESS. THE MINISTRIES OBJECTIVES WILL INCLUDE (BUT NOT  
LIMITED TO) BRINGING THE WORD OF GOD (KJV) INTO THE LIVES OF THE




