**ARTICLES OF INCORPORATION
OF THE
FRANKLIN COUNTY
COMMUNITY MINISTERIAL ALLIANCE, INCORPORATED**

ARTICLE I: NAME OF CORPORATION

The name of the corporation shall be: The Franklin County Community Ministerial Alliance, *Inc*

ARTICLE II: CORPORATION NATURE

This is a nonprofit corporation, organized for the operation, control and management of an entity that provides community services and solicits, receives and distributes or uses funds, professional services, and other services for community and economic development and other charitable, educational purposes.

ARTICLE III: DURATION

The term of existence of the corporation is perpetual, unless dissolved by law.

ARTICLE IV: PURPOSE
General and Specific Purposes

The specific and primary purposes for which this corporation is formed are:

- A. To raise the economic, educational and social levels of the residents of Franklin, County.
- B. To foster and promote community interest and concern for the problems of Franklin County residents.
- C. To expand educational opportunities for the youth of Franklin County by offering a college scholarship to a deserving graduating senior _
- D. To assist the needy by providing clothing, food and other necessities when available.
- E. To aid, support and assist by gifts, contributions or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable, educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
- F. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishments, fostering or attaining the foregoing purposes, whether directly or indirectly and either alone or in conjunction or cooperation with other, whether such other be persons or organizations of any kind or nature, such as

corporations, firms, associations, trusts, institutions, foundations or governmental bureaus, departments of agencies.

- G. All of the foregoing purposes shall be exercised for charitable and educational purposes in such a manner that the corporation will qualify as an exempt organization under 501 (c)(3) of the Internal Revenue Code.

ARTICLE V: MANAGEMENT OF CORPORATION AFFAIRS

- A. Board of Directors. The power of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors, consisting of not less than three (3) persons.

The Directors named herein as the first Board of Directors shall hold office until the first meeting of members at which time an election of Directors shall be named.

Monthly meetings shall be held on the second Saturday of each month at a location designated by the members

- B. Corporate Officers. The Board of Directors shall include the following officers: President, Vice President, Recording Secretary, Corresponding Secretary and Treasurer, and such other officers as the By-Laws of this corporation may authorize. ARTICLE VI: EARNINGS AND ACTIVITIES OF CORPORATION

- A. No part of the net earnings of the corporation shall USED to the benefit of, or be distributed to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services tendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.
- B. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, and intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- C. Notwithstanding any other provision of these articles, the corporation shall not carry out any other activities not permitted to be carries on by a corporation exempt from Federal income Tax under section 5019(c)(3) of the Internal Revenue Code.

ARTICLE VII: MEMBERSHIP

The membership of this corporation shall be classified s AFFILIATED MEMBERS AND INDIVIDUAL MEMBERS.

Qualifications for membership:

- A. AFFILIATE MEMBERS shall be the members of he churches of Franklin County
- B. INDIVIDUAL MEMBERS shall be interested individuals who are not affiliated with any secular or organized religious entity residing in Franklin County.
- C. The initial address of the corporation is: 83 Avenue I Apalachicola, Florida 32320

ARTICLE VIII: FEES, DUES, ASSESSMENTS

- A. Free-Will offerings and other contributions shall come from the members of Franklin County Community Ministerial Alliance and other interested individuals during monthly meetings and fellowship gatherings.

- B. There may, from time-to-time, be occasion to assess the membership for special needs, activities and or events. Such proposed assessment would be only upon special recommendation of the Board of Directors.

ARTICLE IX: DISTRIBUTION OF ASSETS

Upon dissolution of the corporation, the Board of Directors shall after paying or making provisions for the payment of all the liabilities of the corporation, the Board of Directors may dispose of the assets of the corporation exclusively for one or more exempt purposes of the corporation in such manner, and to such organizations organized and operating exclusively for charitable, or educational purposes as shall at the time qualify as an exempt organization.

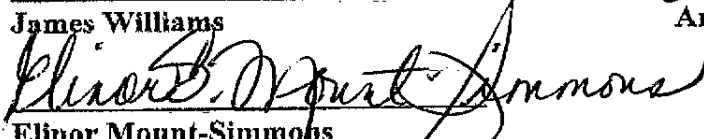
