The undersigned, acting as incorporators of a not for profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be: TAMPA AREA CABDRIVER'S TRUST INC.

ARTICLE II

The principal place of business shall be: 4302-H Ginger Cove Drive, Tampa, Florida 33634

The mailing address of this corporation shall be: 4302-H Ginger Cove Drive, Tampa, Florida 33634

ARTICLE III

The purpose of this not for profit corporation is to perpetuate and defend the rights and security of cabdriver's.
