ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I - NAME AND PRINCIPAL ADDRESS

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purposes for which the corporation is organized are:

We as the Primate Conservancy will maintain a genetically diverse collection of endangered primates, for introduction of future offspring to the wild. To create public awareness of primate conservation. Educating qualified students by working hands on in primate husbandry and conservation.



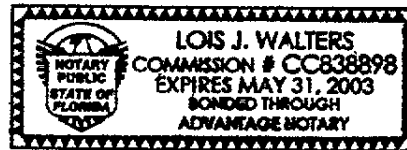


