**ARTICLES OF INCORPORATION  
A FLORIDA CORPORATION NOT FOR PROFIT  
Of Christian Life Ministries, Inc.**

We, the undersigned, citizens of the State of Florida pursuant to Chapter 617 of the Florida Statutes, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida as a corporation not for profit pursuant to the following Articles of Incorporation.

**ARTICLE I NAME**

The name of the Corporation is: Christian Life Ministries, Inc.

**ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business and mailing address of this corporation shall be: business: 6112A Forest City Road, Orlando, Florida 32808; mailing: 556 Little River Loop #236, Altamonte Springs, Florida 32714.

**ARTICLE III PURPOSES**

The purposes for which this corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future provision of any future United States Internal Revenue law. Notwithstanding, any other provision of these articles, this organization shall not carry on any activities not permitted by law as an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law

The corporation shall have the power to buy, own, sell, assign, pledge, mortgage or lease any interest in real estate and personal property and to construct, maintain, and operate improvements thereon necessary or incident to the accomplishment of the purposes set forth herein.

**ARTICLE IV OFFICERS AND BOARD OF DIRECTORS**

The affairs and business of this Corporation shall be conducted and managed by the Board of Directors jointly with the Officers of the Corporation, which Officers shall initially be appointed by the Board of Directors then elected by the membership of the Corporation pursuant to its Bylaws for a period not to exceed 20 years per term. The Corporation Officers shall consist of a President, Vice President, Secretary, and Treasurer. There shall not be less than four (4) persons on the Board of Directors. #### ARTICLE V LIMITATION OF POWERS

There are no limitations of corporate powers as authorized under Section 617.0302, Florida Statutes.

#### ARTICLE VI REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office and registered agent of the Corporation shall be: Larry Cockrell and may be served at: 556 Little River Loop #236, Altamonte Springs, Florida 32714. The undersigned notarized signature connotes acceptance of said designation.

#### ARTICLE VII DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal Government, or to a State or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organization, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE VIII AMENDMENTS

The Articles of Incorporation and Bylaws may be made, altered, amended, or rescinded by a two-thirds (2/3) vote of the Board of Directors or membership present and voting at any regular meeting or specially called meeting for that purpose.

ARTICLE IX. EXISTENCE

The existence of the corporation shall be perpetual.
