AMENDED
ARTICLES OF INCORPORATION
of

Hope in Christ Ministries, Inc.

The undersigned subscribers to these articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

Hope in Christ Ministries, Inc.

ARTICLE II. ADDRESS

The principal place of business and mailing address this corporation in the state of Florida is:

ARTICLE III. NATURE OF BUSINESS

Hope in Christ Ministries, Inc. seeks to provide a channel for individuals to serve in cooperative programs, and to initiate and support neighborhood development projects and to provide a structure through which government and private organizations can channel their resources into the development of projects which serve people. We seek to become involved in compassionate ministries for the needy while giving them the opportunity to work toward the solution of their own personal and community problem.

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the country in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE IV. DIRECTORS

This Board of Directors of the Corporation shall consist of 8 directors and an Executive Director. The number of directors may be either increased or diminished from time to time by the by-laws, but shall never be less than three. Any director may be removed at any time, with or without cause, by a majority vote of the directors at a meeting called for that purpose.

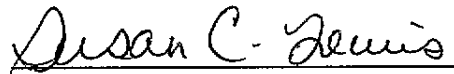
