In compliance with the requirements of Chapter 617 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a not for profit business corporation.

**ARTICLE I**

**NAME**

The name of the corporation (hereinafter called the "Corporation") is Pathways to Literacy, Inc.

**ARTICLE II**
