ARTICLES OF INCORPORATION

I, the undersigned, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purposes of forming a Florida Not For Profit Corporation as set forth below, hereby subscribes to these Articles of Incorporation.

ARTICLE I

The name of the corporation shall be SOUTHWEST FLORIDA BLUEGRASS ASSOCIATION, INC.

ARTICLE II

The purposes and general nature of the business to be conducted and transacted by the corporation shall be as follows:

- A. To do and transact any and all business not for pecuniary profit as permitted under the laws of the State of Florida and the United States of America.
- B. To provide, without limitation, charitable, educational, and cultural purposes including such purposes that the organization shall qualify and an exempt organization under Section 501(c)(3) of the Internal Revenue Code as amended. Notwithstanding, any other provision of these Articles, the organization shall not carry on any activities not permitted to be carried on by any organization exempt from Federal Income Tax under Section 501(c)(3) of the

Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE III

The existence of the corporation shall be perpetual commencing upon the filing of these Articles of Incorporation.

ARTICLE IV

Upon Dissolution of the corporation, assets shall be distributed to the American Cancer Society or in the event the American Cancer Society is not in existence for one or more exempt
