**ARTICLES OF INCORPORATION**  
**OF**  
**EGLISE EVANGELIQUE DE L'ALLIANCE**

**ARTICLE I**

The name of the corporation shall be Eglise Evangelique de L'Alliance of West Palm Beach, Inc.

**ARTICLE II**

The initial principal place of business is 6108 South Dixie Highway, West Palm Beach, Florida 33405.

**ARTICLE III**

The purposes for which this corporation is organized are to preserve and secure the principles of our Christian faith and to govern the body of believers who become members in an orderly manner, to preserve the liberties of each individual member and the freedom of action of the Church in its relation to other Churches.

The objectives of the corporation are the following:

- a) To be a dynamic spiritual organism empowered by the Holy Spirit to share Christ with as many people as possible in this Church, community and throughout the world.
- b) To be a worshiping fellowship, experiencing an awareness of God, recognizing his person, and responding in obedience to his leadership.

- c) To experience an increasingly meaningful fellowship with God and fellow believers.
- d) To help people experience a growing knowledge of God and man.
- e) To be a church that administers unselfishly to persons in the community and world in Jesus' name.
- f) To be a church whose purpose is to be Christlike in daily living by emphasizing total commitment of life, personality and possessions to the lordship of Christ.

#### ARTICLE IV STATEMENT OF FAITH

This corporation which is the legal entity, the members of which constitute the Church, shall be governed by the following statement of faith:

The Holy Bible is the inspired Word of God and is the basis for any statement of faith. The Church subscribes to the doctrinal statement The Baptist Faith and Message as adopted by the Southern Baptist Convention in 1963. We bind ourselves together as a body of baptized believers in Jesus Christ personally committed to sharing the good news of salvation to lost mankind. The ordinances of the Church are baptism and the Lord's Supper.

#### ARTICLE V CONDUCT OF THE AFFAIRS OF THE CORPORATION AND RELATIONSHIPS

Insofar as is practical the corporation will cooperate with and support the Palm Lake Baptist Association and the Florida Baptist Convention or the successors thereof which are affiliated with the Southern Baptist Convention in the geographical area in which the church building is located.

## ARTICLE VI MEMBERSHIP

All members on the rolls of Eglise Evangelique de L'Alliance on the date of the commencement of corporate existence shall be the initial members of this corporation.

## ARTICLE VII OFFICERS AND TRUSTEES

The initial officers of the corporation shall be a President, Vice President, Secretary, Directors and shall be known as Trustees. The By--laws shall provide for the number, manner of election of and duties of all officers and trustees, but ultimate corporate power and authority shall reside in the members to be exercised in the manner and according to the procedures as provided in the By-laws.

## ARTICLE VIII

The By-laws shall provide for the procedure by which persons become members, for discipline and termination of membership, for the selection and duties of the Pastor and staff, the number and manner of election of deacons, the election of a clerk, a treasurer and election and terms of trustees. The By-laws shall also provide for the creation of appropriate committees, nomination and election to committee membership and the duties and responsibilities of the committees. There shall be provisions in the By-laws for the organization of the Sunday School, Training Union, Woman's Missionary Union, Brotherhood and the Church Music Program, provisions of the ordinances of Baptism and Lord's supper, specifying the services, both regular and special, which shall be conducted, providing for regular business meetings and procedure to be followed at such meetings.

The By-laws shall also provide for stewardship, preparation of a budget, appropriate accounting procedures and shall establish the fiscal year of the Church.

Initial adoption of the By-laws shall be in the same manner as provided in Article IX for Amendments to these Articles of Incorporation, Amendments to the By-laws shall be as provided in the By-laws.

#### ARTICLE IX AMENDMENTS

Amendments to these Articles of Incorporation may be made at any regular business meeting of the Church provided that each Amendment shall have been presented in writing at a previous regular or special meeting, and copies of the proposed amendment shall be furnished to each member present. The proposed Amendment to be adopted must pass by a vote of at least two-thirds of all members of the Church present entitled to vote. Only those members in attendance in person or by proxy at the meeting at which the vote to amend is taken shall be entitled to vote thereon.


