ARTICLES OF INCORPORATION

99 SEP 13 AM 10:10

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **TREE OF LIFE MINISTRIES OF THE HOLY SPIRIT, INC.**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 190 NW 9th Avenue, Florida City, FL 33034

ARTICLE III PURPOSES

This corporation is organized exclusively for religious purposes, for relief of the poor, the distressed and particularly, the underprivileged, with specific emphasis on religious programs and instruction and the development of community programs for the elderly, the sick, orphans and foster children, those incarcerated within penal institutions, in order to combat community deterioration; including for such purposes, the solicitation of funds and distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal revenue Code or the corresponding section of any future Federal tax code.

ARTICLE IV DEDICATION AND DISTRIBUTION OF ASSETS

1. DEDICATION OF ASSETS: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

2. DISTRIBUTION OF ASSETS: Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so

disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
