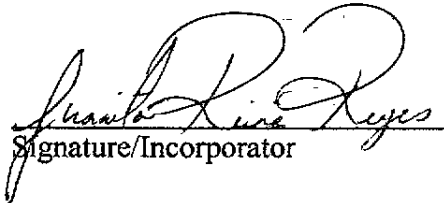
The manner that directors are elected is democratically and by a majority of the votes as stated in the bylaws.

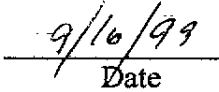

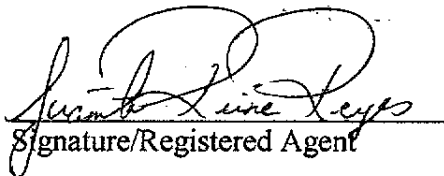
