## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

### ARTICLE I NAME

The name of the corporation shall be: FLORIDA ASSOCIATION OF LOCAL UTILITY REGULATORS, INCORPORATED.

### ARTICLE II PRINCIPAL OFFICE

### ARTICLE IV DIRECTOR APPOINTMENT OR ELECTION

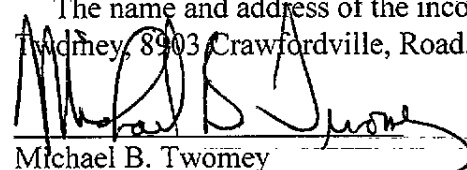
The manner of election or appointment of the Directors is reserved to the by-laws of the corporation.

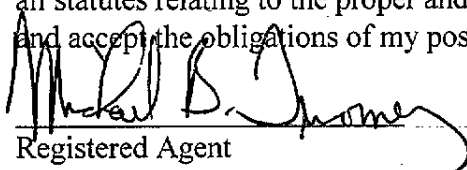
