ARTICLES OF INCORPORATION OF FLORIDA'S WEST COAST LONG-TERM CARE ALLIANCE, INC.

In Compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a not-for-profit corporation.

ARTICLE I - NAME

The name of this Corporation is FLORIDA'S WEST COAST LONG-TERM CARE ALLIANCE, INC.

ARTICLE II - PURPOSE

The purpose of this Corporation shall be to provide educational, research, management and planning service to long term care providers to assist them in providing quality care to Florida's elders. This Corporation shall exist in perpetuity.
