Articles Of Incorporation

Word Of Life Deliverance Center, Inc.

Article I

The name of the corporation shall be: Word Of Life Deliverance Center, Inc.

Article II

The principal place of business and mailing address of this corporation shall be:  
57 N. W. 47 Terrace, Miami, Florida 33127.

Article III

The specific purpose(s) for which the corporation is organized are:

Conduct for religious worship and instruction, churches, schools, pastoriums, and other institutions connected therewith of a religious, educational, charitable and benevolent character, to the end that its own members and others may be generally instructed and guided by the teachings of Jesus Christ; to advance spiritual growth and enlighten, moral and personal purity among its own membership and the people of the community in which it is located; to promote home and foreign missions; and, in general, to advance the teachings of Jesus Christ and the Christian Doctrine.
