
**ARTICLES OF INCORPORATION
OF
THE PEOPLE OUTREACH MINISTRIES, INC.,**

ONE: The name and address of this principal corporation is The People Outreach Ministries, Inc., 1712 Tamarind Avenue, West Palm Beach, Florida 33407. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Public Benefit Corporation Law for Religious purposes. To establish structured support service for Evangelistic, Economic Development and other Ministries to support the outreach ministries for the body of Jesus Christ(The Church). In accordance with the Doctrine of the corporation creed/by-laws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic Development Programs, but, shall not be limited to: Homelessness, Health Care, Child Care, Youth At Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

FOUR: The address of the Registered Office is 1712 Tamarind Avenue, West Palm Beach, Florida 33407, and the name and address of the registered agent of the corporation shall be:

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.


SIX: The Directors are elected in accordance with the By-laws. The name and address of the persons appointed to act as the initial Directors of this corporation are:

SEVEN: The property of this corporation is irrevocably dedicated to Religious purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Religious purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organized and operated exclusively for such purposes.
