ARTICLES OF INCORPORATION

SECRETARY OF STATE The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the proposed corporation shall be LAKE LUCRETIA HOME OWNERS ASSOCIATION, INC.

ARTICLE II PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The Association is not organized for pecuniary gain or profit to the members thereof, and it shall be prohibited from any distribution of income to its members, directors, and officers. The specific purpose for which it is formed is to provide for the maintenance, preservation, and upkeep of the lakes, dams, land and other facilities or common areas of the Association and as may later be acquired, and pertains to all properties owned by the Association.

To promote the health, safety, and welfare of the residents who use the above described property, plus any additions thereto as may hereafter be brought within the jurisdiction of this Association and for this purpose to:

- Exercise all of the powers and privileges and to perform all the duties and obligations of the Association;
- Fix, levy, collect and enforce payment by any lawful means, any charges or assessments Ъ. pursuant to the terms of the by-laws, to pay all expenses in connection herewith and all office and other expenses incident to the conduct of business of the Association, including all licenses, taxes, or governmental charges, if any, levied or imposed against the property of the Association:

- c. Acquire (by gift or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real personal property in connection with the affairs of the Association;
 - d. Borrow money with the assent of one hundred percent of the voting members, mortgage, pledge, deed and trust, or hypothecate any and all of its real or personal property, as security for money borrowed or debts incurred, and
 - C. Have and exercise any and all powers, rights and privileges, which a corporation organized under the non-profit corporation law of the State of Florida, may now or hereafter have or exercise.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

A Board of three directors who are members of the association shall manage the affairs of this corporation. The Board of Directors are elected by a majority vote (51%) of the entire membership and shall serve for a term of two years. The number of directors who manage the affairs of the corporation shall be set forth in the by-laws of this corporation but shall never be less than three.
