
**ARTICLES OF INCORPORATION

- ONE:** The name and address of this principal corporation Abundant Faith Cathedral Church of God, Inc., 708 NW 9th Court, Hallandale, FL 33009. The corporation is organized pursuant to **FLORIDA** Nonprofit Corporation Code.
- TWO:** This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for Religious purposes to establish structured support services for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the Corporation's creed/bylaws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic and Social Development programs, but shall not be limited to: Homeless, Health Care, Child Care, Youth at High Risk, Tutorial, Housing, Job Training, Job Placement, Counseling, Employment, Marriage Ceremonies, Burial Services, Youth and Singles Activities Center, Bookstore, Conferences, Crusades, Revivals, Seminars, Drama (The Arts), Radio, Television, Tape, Video and Book Distribution, other programs to aid those in need and activities to uplift and build the body of Christ.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.
- FOUR:** The address of the REGISTERED office is 708 NW 9th Court, Hallandale, FL 33009, and the name of the registered agent of the corporation shall be:

FIVE:

- (a) This corporation is organized and operated exclusively for Religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

SIX: The Board of Trustees are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Trustees of this corporation are:



EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation, which is organized and operated exclusively for Religious, Charitable and Educational purposes under

Section 501(c)(3) of the Internal Revenue Code. All articles or amendments of the corporation shall be terminated, if at any time be in conflict with the teaching of Jesus Christ. The above articles are in accordance with the 1st and 4th amendments of the U.S. Constitution.
