We, the undersigned, with other persons being desirous of forming a religious corporation not for profit pursuant to the Statutes of the State of Florida, and to that end do make, execute and adopt the following Articles of Incorporation to be known as the "Charter".

ARTICLE I. NAME

The name of the corporation is FIRST HAITIAN BAPTIST CHURCH OF KISSIMMEE, FLORIDA, INC.

ARTICLE II. PURPOSES

The general nature of the objects and purposes of this corporation shall be for the propagation of the gospel of Jesus Christ.

ARTICLE III. QUALIFICATION OF MEMBERS

Membership in this corporation shall consist of all members of the First Haitian Baptist Church of Kissimmee, Florida. Addition or deletion from the rolls of the Church shall automatically add or delete such persons from membership of the corporation.

ARTICLE IV. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI. OFFICERS

Section 1. The Trustees of this corporation shall be the officers and they shall serve until such time as new Trustees are elected or appointed as the By-Laws direct.

Section 2. The officers who shall serve until the first election are:

ARTICLE VII. BOARD OF TRUSTEES

Section 1. The business affairs of this corporation shall be managed by a Board of Trustees consisting of not less than (4) members, three (3) members of the membership at large plus the Pastor. All legal instruments as shall be authorized by the corporation shall be executed by the Chairman of Trustees and attested to by either of the other two members of the membership at large. The number of trustees may be increased from time to time, by the by-laws, but shall never be less than four.

Section 2. The Board of Trustees shall be members of the corporation.

Article VIII. BY-LAWS

The by-laws of this corporation may be amended by a majority vote of its members present and voting at any annual meeting of the church or at a meeting specifically called for that purpose; said proposed change having been placed before the church in writing at a business meeting not less than one (1) month before the time of the proposed action.

ARTICLE IX. AMENDMENTS

Section 1, These Articles of Incorporation may be amended at a special meeting of the membership called for that purpose, by a majority vote of those present.

Section 2. Amendments may also be made at a regular meeting of the membership upon notice given, as provided by the by-laws, of intention to submit such amendments.

ARTICLE X. LOCATION

The location of this corporation shall be at 1700 N. John Young Parkway, Kissimmee, Florida 34741.


ARTICLE XI

This corporation may hold real estate of unlimited value. The corporation is granted all those powers allowed to it under §617.021, Florida Statutes, 1965.


ARTICLE XII


