CERTIFICATE OF AMENDMENT TO

ARTICLES OF INCORPORATION OF

FIRST HAITIAN BAPTIST CHURCH OF KISSIMMEE, FLORIDA, INC.

Pursuant to Article IX of the Charter of First Haitian Baptist Church of Kissimmee, Florida, Inc., filed September 27, 1999, number 593611098, Florida Department of State, amends its charter as follows:

First Amendment as follows:

ARTICLE II. PURPOSES

Is hereby amended to add the following:

- (a) Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that quality as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- (b) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
