AMENDMENT TO THE ARTICLES OF INCORPORATION OF  
TROPICAL GARDENS RESORT CONDOMINIUM ASSOCIATION, INC.

The undersigned does hereby execute, acknowledge and file the following  
Amendment to the Articles of Incorporation of TROPICAL GARDENS RESORT  
CONDOMINIUM ASSOCIATION, INC. (the "Corporation").

1. The name of the Corporation is currently TROPICAL GARDENS  
RESORT CONDOMINIUM ASSOCIATION, INC.
2. The Articles of Incorporation are amended as follows:
  - a. By deleting all of Article I hereof, and by substituting in lieu  
thereof, all of the following:  
  
The name of the Corporation shall be "CORAL FALLS  
CONDOMINIUM ASSOCIATION, INC."
  - b. The Corporations directors and officers shall remain the same
  - c. In all other respects, the Articles of Incorporation shall remain  
unchanged.
3. The Corporation presently has no members or members entitled to vote.
4. This Amendment was adopted by a Unanimous Written Consent of  
Directors in Lieu of Joint Special Meeting signed by directors of  
TROPICAL GARDENS RESORT CONDOMINIUM ASSOCIATION,  
INC. on December 14, 1999 pursuant to Florida Statutes.
5. The effective date of this Amendment shall be upon the filing of these  
Articles of Amendment to Articles of Incorporation with the Secretary of  
State of the State of Florida.

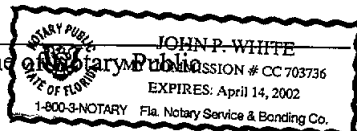
