The undersigned does hereby execute, acknowledge and file the following
Amendment to the Articles of Incorporation of CORAL FALLS CONDOMINIUM
ASSOCIATION, INC. (the "Corporation").

1. The name of the Corporation is currently CORAL FALLS
CONDOMINIUM ASSOCIATION, INC.
2. The Articles of Incorporation are amended as follows:
 - a. By deleting all of Article I hereof, and by substituting in lieu
thereof, all of the following:

The name of the Corporation shall be "CORAL FALLS RESORT

 - b. The Corporations directors and officers shall remain the same
 - c. In all other respects, the Articles of Incorporation shall remain
unchanged.

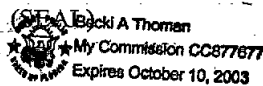
