AMENDMENTS TO ARTICLES OF INCORPORATION

WEST PASCO LADY ROCKETS SOFTBALL ASSOCIATION, INC. 1000

The undersigned not-for-profit Corporation hereby certifies the following:

- 1. The name of the Corporation is West Pasco Lady Rockets Softball Association, Inc.
- 2. The Corporation was formed on September 28, 1999, upon the filing of the Articles of Incorporation in the Office of the Secretary of State, where said Articles were assigned document number N99000005766.
- 3. It is the intention of the Directors of the not-forprofit Corporation that Articles 2, 3, and 5 of the Articles of Incorporation of West Pasco Lady Rockets Softball Association, Inc., be and hereby are amended as follows:

Article 2: Corporate Purpose

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code.

Article 3: Restrictions on Corporate Powers

The Corporation shall possess all powers granted Corporations not-for-profit under the laws of the State of Florida and shall be subject to all restrictions imposed under such corporations and in addition thereto the following restrictions shall pertain:

- 3.01 Net Earnings: No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, trustees, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes.
 - 3.02 Activities: No substantial part of the activities of the

Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal Tax Code) or (b) by a Corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal Tax Code).

Article 5: Disposition of Assets Upon Dissolution

Upon the dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal Government, or to a State of Local Government, for a public purpose.

These amendments are adopted October 4, 2000 by the written agreement of all of the Directors of the Corporation as evidenced by the signatures below and shall become effective upon the filing with the Florida Secretary of State. There are no members entitled to vote.
