ARTICLES OF INCORPORATION
OF

NON-PROFIT CORPORATION

We (I), the undersigned resident(s) of the State of Florida, do hereby associate ourselves together for the purposes of forming a corporation under the statutes of the State of Florida.

ARTICLE ONE
NAME

The name of the corporation shall be Missionary Bible Tabernacle, Inc., and the initial principal office and mailing address shall be 4829 NW 5 Court, Plantation, Florida 33317.

The period of duration of this nonprofit corporation shall be perpetual.

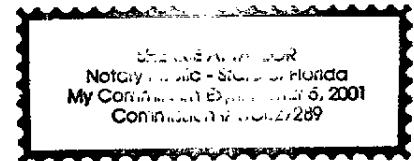
