**ARTICLE III OF INCORPORATION
OF
VOICE OF ALERT WORLD EVANGELISM, Inc.
(EVANGELIZACION MUNDIAL VOZ DE ALERTA, Inc.)**

ARTICLE III - PURPOSES

The objectives and purposes for which this Organization is constituted and this Corporation organized are:

(1) To disseminate the Gospel of Jesus Christ and the Word of God, to the end that people may be evangelized worldwide and believers may be conformed to the image of Jesus Christ; (indoors and outdoors). Such communication shall include but is not limited to all forms of media of communication which include the sponsoring of and participation in radio and television broadcast, the printing and reproduction of music recordings, books, and other materials, the establishment and operation of schools.

(2) To regularly assemble together the members of Churches for fellowship one with another for the purpose of worshipping God in Spirit and in truth.

(3) To preform the holy ordinances given by the Lord Jesus Christ to the Church which included are water baptism by immersion, and the practice of the Lord's Supper.

(4) To preform other ministry which included but are not limited to: praying for the sick and anointing them with oil, to conduct weddings and funerals and to dedicate infants.

(5) To involved every member of the Body of Christ in the work of the ministry for the building of the Kingdom of God, recognizing and equipping them to the ministry to which they have been called.

(6) To license and ordain ministers; to send forth and maintain ministers, missionaries and other workers, and to establish and maintain other churches and institutions, whether foreign or domestic, dedicated to the propagation of the Gospel of Jesus Christ.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The administrative affairs of this Corporation shall be directed by a Board of Directors, with the Presiding Minister as President of the Corporation, who shall act as the Chairman of the Board. The Board of Directors shall consist of no less than three members. The number of Directors may increase in accordance with the needs of the Corporation as determined from time to time by the Board of Directors. Each Director must meet the requirements for leadership set forth in I Timothy 3:1-7; Titus 1:5-9, demonstrating faithfulness to the Lord Jesus Christ, to His Church and to its leadership.

The authority of the Board of Directors will be subject to the Principals of the Word of God, to the laws of State of Florida concerning non-profit organizations, to this constitution and by-laws and to any rules or by-laws adopted by the Board of Directors.

The Board of Directors will have the authority to appoint additional members for positions on the Board of Directors. Potential members for the Board of Directors, appointed by the Board of the Directors, may be allowed to serve in the appointed role for the given time. In the event of a vacancy on the Board of Directors, whether caused by resignation, removal, death, or expansion of the Board of Directors, the Directors then serving shall select the best qualified person from names presented by the presiding President.

If the Board of Directors, after due Biblical examination, shall determine that a Member or a Director no longer fulfills the requirements of a Member or a Director, he shall be removed from his position.
