**ARTICLES OF INCORPORATION  
OF  
COMMUNITY ALLIANCE  
FOR REFORM IN EDUCATION, INC.**

The undersigned, by these Articles, associate themselves for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes and certify as follows:

**ARTICLE I  
NAME**

The name of the corporation shall be:

**COMMUNITY ALLIANCE FOR REFORM IN EDUCATION, INC.**

Its initial address is 423 Fern Street, Suite 220, West Palm Beach, Florida 33401. For convenience, the corporation shall be referred to in this instrument as the Corporation.

**ARTICLE II  
DURATION**

The duration of the Corporation shall be perpetual.

**ARTICLE III  
PURPOSE**

The purpose for which the Corporation is organized is to work towards achieving systematic educational reform in Palm Beach County to ensure equitable access to quality education for all students and for any other purpose permitted by law not for pecuniary profit.

**ARTICLE VIII  
INDEMNIFICATION**

To the extent permitted under Florida Statutes, every director and every officer of the Corporation shall be indemnified by the Association against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him or her in connection with any proceeding or any settlement of any proceeding to which he or she may be a party or in which he or she may become involved by reason of his or her being or having been a director or officer of the Corporation, whether or not he or she is a director or officer at the time such expenses are incurred, except when the director or officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his duties; provided that in the event of a settlement the indemnification shall apply only when the Board of Directors approves such settlement and reimbursement as being for the best interests of the Corporation. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.
