ONE: The name and address of the principal corporation is COALITION FOR BLACK STUDENT ACHIEVEMENT, INC. in Palm Beach County, Florida.

The corporation is organized pursuant to the Florida Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person.

The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to pursue every available avenue to ensure that Black students in Palm Beach County schools reach high levels of academic achievement.

THREE: The duration of this corporation shall be perpetual and shall be operated on a non stock basis within the meaning of the Florida Not-For-Profit Corporation Act and shall not have the power to issue shares of any type or class of stock.

FOUR: The address of the registered office is 1914 37<sup>th</sup> Street, West Palm Beach in Palm Beach County, Florida. The name of the registered agent is Debra L. Robinson.

FIVE:

- (a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)3 of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)3 of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) if the Internal Revenue Code

SIX: Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated for such purposes.

SEVEN: The Board of Directors shall have an odd number of members between seven and seventeen inclusive. The bylaws shall provide the election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three. 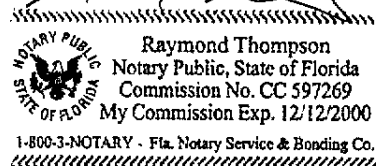
NINE: The name of the incorporator of the corporation is Debra L. Robinson.
