

ARTICLES OF INCORPORATION

OF

Naples Natural Health & Education Center, Inc.

A NON-PROFIT CORPORATION

The undersigned incorporator, in order to form a non-profit corporation under the laws of the state of Florida, adopt the following Articles of Incorporation:

ONE: The name of this corporation is Naples Natural Health & Education Center, Inc.

TWO: The address of this corporation is 4035 Tenth Street No., Naples, Florida 34103.

THREE: The name and address of the registered agent of this corporation is:

FOUR: The specific purposes for which this corporation is organized are to offer continuing education programs for professional health care individuals and groups, as well as health-related programs for the general public. Additionally, this corporation will offer programs and courses across the entire spectrum of health care, including natural and alternative health care options, in the fields of acupuncture, chiropractic, health care administration, allopathic medical practitioners, marriage and family therapy, massage therapy, medical technology, mental health counseling, physical therapy, nursing, nutrition and dietetics, psychology, social work, and other health-related areas. This corporation is authorized to provide education in the forms of programs, classes, courses, resources, literature, internet offerings, and all other methods of accomplishing the aforesaid purposes. In support of the aforesaid purposes, the corporation is authorized to conduct business, open bank accounts, buy and sell property, and

generally engage in all activities authorized for non-profit corporations.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

FIVE: The number of initial directors of this corporation is four (4).

The manner of election of the Directors shall be in accordance with the provisions of the bylaws of this corporation.

SIX: The name and address of the incorporator of this corporation is:

SEVEN: The period of duration of this corporation is perpetual.

EIGHT: Additional provisions for the operation of the corporation are as follows:

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or


intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
