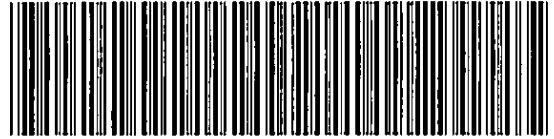

**AMENDMENT TO THE ARTICLES OF INCORPORATION OF
CASCADE LAKES RESIDENTS ASSOCIATION, INC.**

The Amended and Restated Declaration of Conditions, Covenants, Easements and Restrictions for Cascade Lakes is recorded in Official Records Book 30569, beginning at Page 322, of the Public Records of Palm Beach County, Florida. The original Declaration of Conditions, Covenants, Easements and Restrictions for Cascade Lakes is recorded in Official Records Book 11829, beginning at Page 1817 of the Public Records of Palm Beach County, Florida

As indicated herein, words underlined are added and words ~~struck through~~ are deleted.

Item 2. Article XII of the Articles of Incorporation of Cascade Lakes Residents' Association, Inc., shall be amended as follows:

**ARTICLE XII
AMENDMENTS**

Amendment of these Articles of incorporation requires the approval of at least sixty-six and two-thirds percent (66 2/3%) of the Members, present and voting, in person or by proxy, or by secret absentee ballot, pursuant to the Bylaws, in the same manner as voting in the election of directors, at a meeting at which a quorum is established, or by written agreement, so long as at least a quorum of the Members participates.
