ARTICLE ONE - NAME

SECRETARY OF STATE

The name of this Corporation shall be GRACE & TRUTH HOLINESS DELIVERENCE CHURCH OF LOUGHMAN, INC., with its principal place of Business located at 601 HIGHWAY 17-92 & PARKER ROAD, LOUGHMAN, POLK COUNTY FLORIDA.

ARTICLE TWO - DURATION

The Corporation shall have a perpetual existence, Commencing on the Date of filing.

ARTICLE THREE - PURPOSE
