# 03 SEP 26 AM 9: 18 SADDLEBROOK VILLAGE WEST HOMEOWNERS ASSOCIATION (a corporation not-for-profit)

- The name of the corporation is Saddlebrook Village West Homeowners? Ï. Association, Inc.
- The Articles of Incorporation of Saddlebrook Village West Homeowners Π. Association, Inc. are hereby amended by deleting all references to the corporation name "Saddlebrook Village West Homeowners Association, Inc." and replacing it with the new corporation name of "Westbrook Estates Homeowners Association, Inc." for the sole purpose of changing the name of the corporation.
- At a regular meeting of the Members of the corporation, held on the 17th day of III. July, 2003, for which notice was given of the intent to amend these Articles, and at which a quorum was present, a vote of greater than two-thirds (2/3) of the Members present and voting was held in favor of adopting this Amendment. A two-thirds (2/3) vote of the Members was sufficient for approval.
