ARTICLES OF INCORPORATION
OF

- ONE: The name and address of this principal corporation is Alpha 2000 Com. Development, Inc. 4011 NW 4th CT. Coconut CK, FL 33066 in BROWARD County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.
- TWO: This corporation is a non-profit Public Benefit Corporation and is organized to aid mankind through Economic and Community Development Programs. The corporation is organized under the Non-profit Public Benefit Corporation Laws. The programs will consist of Economic Development Programs, but shall not be limited to: Homelessness, Health Care, Child Care, Youth At High Risk, Tutorial, Land Acquisition, Housing Job Training, Counseling, Employment, Telemarketing, Helping underprivileged children, Assisting other Non-Profit Organizations in providing food, clothing, and finances to those in need, and other support programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

- (a) This corporation is organized and operated exclusively for religious purposes within meaning of Section 501 (C) (3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Any such assets not disposed of shall be disposed of by the Superior Court of the County in which the principal office or organization as said Court shall determine which are organized and operated exclusively such purposes.
