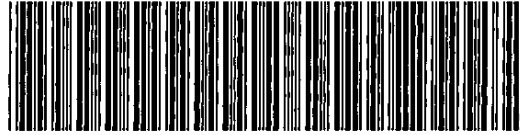



Pursuant to the provision of Section 607.1002(2) of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation:

1. The name of the corporation is **TEAM FLORIDA WEIGHTLIFTING, INC.**
2. The following amendment to the Articles of Incorporation were adopted by the directors of the corporation and by a majority of the Board of Directors of the corporation on the 31st day of January, 2007.


