The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

Philadelphia Church of God Ministries, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

This corporation is a not-for-profit corporation organized under Chaprte 617, Florida Statutes. It is not organized for the private gain of any person.

The specific purposes of the corporation will be

- 1. To engage in religious activities for the promotion of the gospel of Jesus Christ through pursuing the prescription of the great commission as stated in the Holy Bible (Matt. 28:19,20).*
- 2. The publication and distribution of literature concerning crime, the fear of crime, illiteracy, and the prevention of alcohol, tobacco, substance abuse, and other social ills.*
- 3. The recruitment and training of community volunteers who would assist in the community in reaching others in delivering the message of the Great Commission.*
- 4. Provided, however, that the corporation shall not engage in any action that is not permitted to be carried on by non-profit corporations under the internal revenue code and no part of net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.*
