## ARTICLES OF INCORPORATION

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

### **ARTICLE I NAME**

The name of the corporation shall be: FRIENDS OF THE FAMILY OF JESUS, HEALER INC.

### **ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 4129 N. Armenia Ave., Tampa, Florida 33607

### **ARTICLE III PURPOSE(S)**

The purpose for which the corporation is organized is as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this Corporation are:

1. To assist in the spread of the Gospel of Jesus Christ and His Church and to propagate the Catholic Faith world-wide by the use of all lawful means and endeavors.
2. In the furtherance of the purpose stated in A 1 above the Corporation is organized and operated exclusively for the benefit of, and to carry out the purposes of The FAMILY OF JESUS, HEALER a Roman Catholic Religious Community of Priests, Brothers, Sisters and lay associates.
3. In the furtherance of the purpose stated in A 1 and A 2 above to deal in and with any kind of property, real, personal or mixed, including but not limited to the construction, acquisition and operation of rectories, convents, monasteries, seminaries and lay houses to be utilized for and on behalf of THE FAMILY OF JESUS HEALER.
4. To convene or sponsor apologetic conferences, parish missions and other inspirational, educational, and evangelical meetings.
5. To use whatever means appropriate to enhance and expand the operations of the Corporation in the furtherance of its purposes; to carry out advertising, public relations and fund raising in that behalf.
6. To make, do and execute each and every other act, thing, or deed necessary or desirable in pursuance of the Corporate purposes, in any lawful manner anywhere in the world.

B. To exercise all rights and powers conferred by the Laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried out by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.
