ARTICLES OF INCORPORATION

BAYSIDE COMMERCIAL OWNERS ASSOCIATION, INC., a Florida corporation not for profit

The undersigned, acting as incorporators of a corporation not for profit under the Florida Not For Profit Corporations Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is BAYSIDE COMMERCIAL OWNERS ASSOCIATION, INC. (referred to herein as the "Corporation" or the "Association").

ARTICLE II. TERM OF EXISTENCE

The Corporation shall exist perpetually or until terminated as provided by law.

ARTICLE III. ADDRESS OF CORPORATION

The mailing address and the street address of the initial principal office is 220 McKenzie Avenue, Panama City, FL, 32401.

ARTICLE IV PURPOSE

The general nature, objects and purpose of the Corporation are:

- (1) To provide an entity responsible for owning, maintaining, controlling and preserving the Association Property and maintaining other property over which the Association holds easements in the development located on Thomas Drive in Bay County, Panama City, Florida, and legally described as set forth in Exhibit "A" attached hereto, (the "Development").
- (2) To provide for administrative, legal, accounting and financial services, and such other services necessary to accomplish the obligations set out above.
- (3) To replace, improve, maintain and repair such structures, landscaping and paving, both real and personal, as the Board of Directors in its discretion determines necessary, appropriate, and/or convenient.

(4) To operate without profit for the sole and exclusive benefit of its Members (defined below).

ARTICLE V. MEMBERS

Every fee simple owner of a parcel of real property in the Development shall be a member of the Association during the time of such ownership. Membership shall be mandatory for all parcel owners and all members of the Association shall be governed and controlled by these Articles, the By-Laws, and any covenants and restrictions encumbering the property.

ARTICLE VI. INITIAL REGISTERED AGENT AND REGISTERED OFFICE

The name of the initial registered agent of the Corporation is J. Robert Hughes, Esq., and the street address of the initial registered office of the Corporation is 220 McKenzie Avenue, Panama City, FL, 32401.

ARTICLE VII. FIRST BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board of Directors. The Board of Directors shall initially consist of three (3) Directors appointed by the Developer. Thereafter, the election or appointment of the Board of Directors shall be regulated in accordance with the By-Laws of the Association.
