OF

The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Community employment, to reach and educate the masses of children from birth through kindergarten. After school care for first through six grade. Community programs for teens. By providing homework assistance computer classes, field trips, youth tutoring youth, and seminars to involved and equip the parents.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.


SIX: The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:
