# THE CIRCLE OF PRAYER MINISTRIES OF FLORIDA, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

#### <u>ARTICLE 1 - NAME</u>

The name of the Corporation is THE CIRCLE OF PRAYER MINISTRIES OF FLORIDA, INC., (hereinafter, "Corporation).

#### ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida mainly for ministries.

#### **ARTICLE 3 - PRINCIPAL OFFICE**

#### ARTICLE 7 - TERM OF EXISTENCE

This Corporation shall have perpetual existence.
